#### **WCB Update**

#### How the Alberta economy is impacting employer

We are calling employers to understand the impacts the current Alberta economy is having on their business. This will help us confirm information for the 2020 premium relief program and assist us with 2021 rate setting.

#### The Canadian Emergency Wage Subsidy (CEWS)

- If you are receiving CEWS and your worker is actively working for you, the earnings are assessable
- If you are receiving CEWS and your worker is at home on furlough (paid via CEWS and not drawing from EI), then the earnings are not assessable

#### **Keeping your data safe**

- We became aware of a financial scam where callers are pretending to be from WCB
- Please be assured that your information is safe and none of our systems have been compromised
- If you encounter this situation, visit our website to find directions on how to report this

#### WCB Update - Cont'd

#### **COVID-19 Cost Relief Update**

- We are offering cost relief to employers with COVID-19 claims and costs related to the provincial shutdown earlier this year
- Employers will automatically receive cost relief for these claims so their PIR refunds in 2021 and their experience rating in 2022 are not impacted

### **COVID-19 COR Changes**

- Allowing documentation only audits until December
- 1-year COR internal auditor
- 3-year COR external auditor or CP staff, recertifying in 2020
- No more 90-day extensions as end of year approaching
- Does not effect PIR refunds



## **Auditing 2021**

- Interviews and Observations will be brought back next year
- CP group working to create guidelines for auditors oh how to complete these verification techniques
- AMHSA has a member sitting on the working group



## Fixed COR Date and ISO/CSA Equivalency

- Have current COR expiry date fixed
- Allowed to complete audit within 60 days prior to fixed date – if outside timeline new fixed date is done
- New standard allows for COR equivalencies for ISO 45001:2018, CSA Z45001:19 and CSA Z1000:14 – both certification and maintenance
- Certification must be issued from a designated certification body
- If certification only covers part of operations, then
   COR will be issued as a site-specific

#### **Off-Site Audit Review**

- Change to process due to COVID-19
- Will be collecting employer's documentation either from sites or electronically
- Review by OSA Reviewer will be done remotely
- Interview with employer representative will be done over video chat or phone



## **COR Working Groups**

- 3 groups out of items from the COR Strategic Plan
- COR Harmonization
  - Across provinces; working on performance metrics that could be beneficial for both the program and employers
- Auditor Training/Certification Standardization
  - All auditors receive same standardized training
- Risk Based Scalable Audit/COR Plus/Accreditation
  - COR Plus/Accreditation for higher performers
  - Looking at audit tools to be risk based and scalable

## **COR Certification 2020**

- Peer process coordinated for 30 municipalities and consultant auditors for 15+
- Extraordinary circumstances internal auditors
- Minimum 3 months documentation required
  - Example
- 3-year COR for Recertifications
  - 1-year CORs issued prior to announcement have been extended
  - Not available for lapsed or new CORs



## ISO 45001:2018

- COR Equivalency is granted to ISO certified employers
- Hosted ISO 45001:2018 Requirements, Internal Auditor, and Lead Auditor training in August/September through SGS Academy (ISO 45001 Registrar)
- Attended by AMHSA employees, peer Health and Safety Associations, and municipal auditors
- Additional offerings to be hosted by AMHSA, contact Shannon for waiting list





## **OSAR 2020**



- Expecting approximately 10 off site audit reviews to be conducted by Partnerships
- Once completed, follow-up will be completed with the auditors by AMHSA

#### **COR Certification Announcement**

Great news! The COR program has just introduced a new option to help those employers who have completed a full three-year audit cycle (2017 to 2019) and now must re-certify their COR in 2020 during the COVID pandemic. This option qualifies for PIR refund eligibility from WCB.






## **PSI** Reporting










#### WCB Claim Data - Cities Removed






#### Total Cost of WCB Claims 2019






#### Claims by Occupational Category (2017-YTD 2020)






## Trades: Body Parts Injured






#### Head Injuries: Trades and Equipment Operators






#### Head Injuries – Type of Accident - Trades






### Head Injuries – Type of Accident – Equip Ops






## Musculoskeletal Injuries (MSI)








#### **Seasonal Workers**






### Mechanism of Injury – New Workers






#### Corrective Actions Reported by Type of PSI






### **Exposure to Harmful Substance**










#### Percent of Hazards Identified by Energy Type













#### Claims Per Month – Trades and Office








#### Primary Source of Injury: October to March








## Primary Source of Fall Injuries October to March








#### Fall Injuries by Occupation




#### Top 10 Body Part PSI – Alberta Municipalities






#### Primary Source of Injury: October to March








### Primary Source of Fall Injuries: Oct to March








## Fall Injuries by Occupation






### Top 10 Body Part PSI - Alberta Municipalities
