- Fuel thefts have been very common throughout Alberta amongst many municipalities.
- Mental and Psychological Health are a big focus for most municipalities.

- Reports on incidents resulting in equipment damages.
- Couple harassment/bullying claims, and COVID claims.
- Friendly Reminder: Review your tire manufacturing dates to reduce blowout possibilities
- Question Posted in Forums: installed a hydro dump station
- Safety Alert PW June 1, 2022 regarding slip off pay loader step (PP Attached)
 - Reminder of three point of contact, and mounting/dismounting vehicles safely
 - Reminder to face the vehicle when mounting and dismounting as more muscles are engaged and is safer
- Remember to review your pre-trip inspection process, and post trip inspection of vehicles and equipment
